NOTIFICATION

G. O. (P) No. 13/2012/TD. Dated, Thiruvananthapuram, 14th February, 2012.

S. R. O. No. 93/2012.—In exercise of the powers conferred by sections 18A, 24 and 29 of the Abkari Act 1 of 1077, the Government of Kerala hereby make the following rules further to amend the Foreign Liquor Rules, issued by notification No. SR 4-1859/52/RD dated 17th January, 1953 and published in the Travancore-Cochin Gazette Extraordinary No. 2 dated 17th January, 1953, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Foreign Liquor (2nd Amendment), Rules, 2011.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Foreign Liquor Rules,—

(i) in the Rules and in the Forms thereto, for the words and symbol "ALCOHOL CONSUMPTION IS INJURIOUS TO HEALTH—മദ്യപാനം ആരോഗ്യത്തിന് ഹാനികരം", wherever they occur, the words and symbol "ALCOHOL CONSUMPTION IS INJURIOUS TO HEALTH—മദ്യപാനം ആരോഗ്യത്തിന് ഹാനികരം" and "DRUNKEN DRIVING IS PUNISHABLE—മദ്യപിച്ചു വാഹനം ഓടിക്കുന്നത് ശിക്ഷാർഹമാണ്" shall be substituted;

(ii) in Rule 23,—

(a) in sub-rule (3), after the words and figures "for 180 ML bottles and above", the words and figures "upto 500 ML" shall be added;

(b) the Note shall be omitted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 272/2010/TD dated 29th November, 2010 published as S. R. O. No. 1095/2010 in the Kerala Gazette Extraordinary No. 2718 dated 29th November 2010, the Government have amended the Kerala Foreign Liquor (Compounding, Blending and Bottling) Rules, 1975 to incorporate the statutory warning "DRUNKEN DRIVING IS PUNISHABLE—മദ്യപിച്ചു വാഹനം ഓടിക്കുന്നത് ശിക്ഷാർഹമാണ്". Similar amendments are therefore to be incorporated in the Foreign Liquor Rules and in the Forms of license prescribed therein. Hence, the Government have decided to amend the Foreign Liquor Rules for the Purpose.

The notification is intended to achieve the above object.
