**S. R. O. No. 94/2012.**—In exercise of the powers conferred by sections 24 and 29 of the Abkari Act 1 of 1977, the Government of Kerala hereby make the following rules further to amend the Foreign Liquor Rules issued by notification No. SR 4-1859/52/RD dated 17th January, 1953 and published in the Travancore-Cochin Gazette Extraordinary No. 2 dated 17th January, 1953, namely:—

**RULES**

1. *Short title and commencement.*—(1) These rules may be called the Foreign Liquor (3rd Amendment) Rules, 2012.  
(2) They shall come into force at once.

2. *Amendment of the Rules*.—In the Foreign Liquor Rules,—

- (1) in rule 28 A, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (2) in Form FL 1, in condition number 16, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (3) in Form FL 3, in condition number 20A, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (4) in Form FL 4, in condition number 2A, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (5) in Form FL 4A, in condition number 18, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (6) in Form FL 11, in condition number 9, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (7) in Form FL 12, in condition number 9, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;
- (8) in Form FL 13, in condition number 8, after item (vii) and the entry against it, the following item and entry shall be inserted, namely:—  
“(viii) Good Friday.”;

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

In the Abkari Policy declared for the year 2011-12, vide G. O. (Ms.) No. 107/2011/TD dated 17th August, 2011, the Government have decided to treat “Good Friday” as a Dry Day. In order to give statutory validity to the above decision, the Foreign Liquor Rules needs to be amended suitably.

The notification is intended to achieve the above object.
