S. R. O. No. 598/2014.—In exercise of the powers conferred by sections 18A and 29 of the Abkari Act, I of 1077, the Government of Kerala hereby make the following rules further to amend the Kerala Abkari Shops Disposal Rules, 2002, issued under G. O. (P) No. 24/2002/TD dated 30th March, 2002 and published as S.R.O. No. 198/2002 in the Kerala Gazette Extraordinary No. 376 dated 30th March, 2002, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Abkari Shops Disposal (Amendment) Rules, 2014.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—(1) In the Kerala Abkari Shops Disposal Rules, 2002, in rule 7, in sub rule (11) after clause (ix), the following clause shall be inserted, namely:—

“(x) All Sundays.”

(ii) for the existing proviso the following proviso shall be substituted, namely:—

“Provided that the toddy shops shall be allowed to function on all Sundays and on the first day of all English Calendar Months”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

In the Abkari Policy announced for the year 2014-15, vide G. O. (Ms.) No. 139/14/TD dated 22nd August, 2014, the Government have decided to declare “All Sundays” as Dry Days from 5th day of October, 2014. In order to give statutory validity to the above said decision the Kerala Abkari Shops Disposal Rules, 2002 needs to be amended suitably.

The notification is intended to achieve the above object.
