**S. R. O. No. 153/2015.**—In exercise of the powers conferred by sections 18 A and 29 of the Abkari Act, 1 of 1077, the Government of Kerala hereby make the following rules further to amend the Kerala Abkari Shops Disposal Rules, 2002, issued under G. O. (P) No. 24/2002/TD dated 30th March, 2002 and published as S.R.O. No. 198/2002 in the Kerala Gazette Extraordinary No. 376 dated 30th March, 2002, namely:—

## RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Abkari Shops Disposal (Amendment) Rules, 2015.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Abkari Shops Disposal Rules, 2002,—

(1) in rule 5, in sub-rule (12), for the figure and words “10th of January”, the figure and words “31st March” shall be substituted;

(2) in rule 7, in sub-rule (26), for the figure and word “10th January”, the figure and words “31st March” shall be substituted;

(3) In Form No. III ‘AGREEMENT’, under the heading ‘ഉടമ്പടി’ in the first paragraph, for the words and figure “ഒന്തൊതി മാസം 10-ാം തീയതിക്കു”, the words and figure “മാർച്ച് മാസം 31-ാം തീയതിക്കു” shall be substituted;

#### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the Kerala Abkari Shops Disposal Rules, 2002, the time limit for the remittance of annual rental of toddy shops for the succeeding Abkari year is 10th January of the current Abkari year. The district level officers of the Excise Department have reported the practical difficulty in obtaining the connected certificates required for this remittance before the end of the Financial Year. Hence Government have decided to extend the said time limit from 10th January to 31st March of the current Abkari year. For this purpose, the said Rules needs to be amended.

The notification is intended to achieve the above object.
