(P) No.66/2008/TD dated 27th March, 2008 and published as S.R.O.No.322/2008 in the Kerala Gazette Extraordinary No.617 dated 27th March, 2008, shall be Rs.63,00,000 (Rupees sixty three lakhs only) each for the year 2013-2014, subject to the decision to be taken by the Government upon the report of the Justice (Rtd.) Ramachandran Commission.

RULES

1. Short title and commencement.– (1) These rules may be called the Foreign Liquor (4th Amendment), Rules, 2013.

(2) They shall come into force at once.

2. Amendment of the Rules.- In the Foreign Liquor Rules,-

(1) in rule 13,-

(a) in sub-rule (3), for the letters, figures, brackets and words “Rs.22,00,000 (Rupees twenty two lakhs only)” the figures, letters, brackets and words, “Rs. 23,00,000 (Rupees twenty three lakhs)” shall be substituted;

(b) in sub-rule (3A), for the figures letters, brackets and words “Rs.20,000(Rupees twenty thousand only)” the letters, figures, brackets and words “Rs.25,000(Rupees twenty five thousand) ” shall be substituted;

(c) in the third proviso to sub-rule (3B), for the letters, figures, brackets and words “Rs.25,000 (Rupees twenty five thousand only)” the letters, figures, brackets and words “Rs.30,000 (Rupees thirty thousand) ” shall be substituted;

(d) in the proviso to sub-rule (3C), for the letters, figures, brackets and words “Rs.25,000 (Rupees twenty five thousand only)” the letters,
