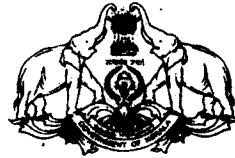

S. R. O. No. 353/2014.—In exercise of the powers conferred by section 18A of the Abkari Act, 1 of 1077, read with sub-rule (1) of rule 3 and rule 4 of Kerala Abkari Shops Disposal Rules, 2002, and all other powers vested in Government in this regard, the Government of Kerala hereby make the following further amendments to the notification issued under G. O. (P) No. 58/2008/TD dated 19th March, 2008 and published as S. R. O. No. 291/2008 in the Kerala Gazette No. 558 dated 19th March, 2008, namely:—

AMENDMENT

In the Schedule to the said notification, in the Appendix, under the heading “പാലക്കാട് ജില്ല” under the sub-heading “ചിറ്റൂർ താലൂക്ക്-ചിറ്റൂർ റേഞ്ച്-കളക്ട്.”—

- (i) against shop no. 22, for the entries in column 4, the following entries shall be substituted, namely:—

“വടക്ക്—വടവന്നൂർ വില്ലേജിന്റെ വടക്കേ അതിർത്തി, കിഴക്ക്—മീങ്കര മെയിൻ കനാൽ, തെക്ക്—മീങ്കര കനാൽ, പടിഞ്ഞാറ്—മീങ്കര കനാൽ”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the notification issued under G. O. (P) No. 58/2008/TD dated 19th March, 2008 and published as S.R.O. No. 291/2008 in the Kerala Gazette No. 558 dated 19th March, 2008, the Government have notified the number of independent toddy shops in each range and the limits within which the shops are to be located. The Excise commissioner has requested the Government to reschedule the limits of Toddy Shop No. 22 of the Chittur Range of Palakkad Division since there is some vacant space in the northern part, outside the schedule limit Toddy Shop No. 22 which was not included in any of the schedule limits of any toddy shops. Hence the Government have decided to change the schedule limits of Toddy Shop No. 22 for the smooth functioning of Toddy shop No. 22 in order to include the vacant space to the scheduled limit of Toddy Shop No. 22 of Chittur Range, for which S. R. O. 291/2008 has to be amended.

The notification is intended to achieve the above object.
