S. R. O. No. 57/2016.—In exercise of the powers conferred by section 29 read with sections 12 and 24 of the Abkari Act 1077 (1 of 1077), the Government of Kerala hereby make the following rules further to amend the Kerala Sweet Toddy (NEERA) Rules, 2014 issued under notification G. O. (P) No. 27/2014/TD, dated 14th February, 2014 and published as S. R. O. No. 116/2014 in the Kerala Gazette Extraordinary No. 514 dated 14th February, 2014, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Sweet Toddy (NEERA) (Amendment) Rules, 2015.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Sweet Toddy (NEERA) Rules, 2014, in rule 2, in clause (b), after the words “Agro Industries Corporation” the words “the Kerala Kerakarshaka Sahakarana Federation Ltd. (KERAFED)” shall be inserted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government vide G. O. (Ms.) No.111/2015/Agri., dated 22nd June, 2015, have decided to include “the Kerala Kerakarshaka Sahakarana Federation Ltd (KERAFED)” in the definition of the term “applicant” in the Kerala Sweet Toddy (NEERA) Rules, 2014. The Kerala Sweet Toddy (NEERA) Rules, 2014 needs to be amended for the above purpose.

The notification is intended to achieve the above object.
