ORDER

1. In partial modification to the Government Order read 2nd above, the following ex-cadre posts are created for a period of one year with immediate effect and the following transfers and postings of IPS officers are ordered with immediate effect.

1(i). An ex-cadre post of the Director General of Police (Prisons) is created (in Level 16 of the Pay Matrix with Pay Scale Rs.205400-224400) for a period of one year and this post is declared equivalent in status and responsibility to the cadre post of the Director, Vigilance & Anti-Corruption Bureau under Rule 12 of IPS(Pay) Rules, 2016.

1(ii) Sanction accorded vide Government Order 1st cited for the continuance of the ex-cadre post of the Excise Commissioner is hereby cancelled. An ex-cadre post of the Excise Commissioner is created instead (in Level 15 of the Pay Matrix with Pay Scale Rs.182200-224100) for a period of one year and this post is declared equivalent in status and responsibility to the cadre post of Additional Director General of Police (Headquarters) under Rule 12 of IPS(Pay)Rules,2016.

2. Shri Rishi Raj Singh IPS (KL:1985), Excise Commissioner, is transferred and posted as Director General of Police (Prisons) against the ex-cadre post created vide para 1(i) above.

3. Shri. S. Aananthakrishnan IPS (KL: 1989), Additional Director General of Police, Headquarters is transferred and posted as Excise Commissioner, against the ex-cadre post created vide para 1(ii) above.

4. Government Order issued vide reference 2nd cited stands modified to that extent.
